REPORTS AND COMMENTS

Superintendent Report

- Budget Status (11/30/2022) District Budget reflected activity with a new payment posted so
 the investment account balance is about \$1.9 Million. Had a hefty bill paying month since
 bills from the beginning of the school year have finally come in and have been paid along
 with the purchase of the new bus. The district will not see another payment from the State
 Department of Education until after the new year. But for now, the district is reflecting an
 expected balance compared to what was budgeted. Food Service is at about \$20,000 and is
 slowly building back up. This account to continue monitoring as the district continues
 through the rest of the school year.
- Upcoming Board Workshop scheduled for February 2023 discussion for a date when the
 board members and student delegation will meet exchanging ideas and goals always brings
 a productive and positive result for all involved. Superintendent Felgenhauer asked if
 anyone would be interest in conducting training sessions. The possibility of bringing in
 someone from the ISBA to provide a training workshop is a good option. The event will be
 at Hells Canyon Grand Hotel.

- Enrollment Report current enrollment at the school is 135 students which includes Dual Enrolled Students not on Campus.
 - First Friday The December "First Friday" was December 2nd and it was canceled due to a snow day.
 - Dental Sealants We had approximately 13 students participate in the dental sealant program at the end of November.

- Lockdown Drill on November 29th a lockdown drill was conducted. It went very smoothly.
- Guest Speaker on December 19th, Larry Campbell (local historian, parent of graduate of Tiyapo Campell and Native American cultural authority) who will be teaching about the Native American culture. He will present to the whole school from 2-3pm with a question and answer session for the 7-12 students from 3:00-3:30pm.
- JH Basketball Our basketball team will play our final home game tomorrow here. We have yet to win but the kids are making good progress.
